**Angel Park General Information**

1. Picnic Pavilion (60 person maximum) or Amphitheater (150 person maximum). Rental fees up to 2 hours -\$175, up to 3 hours - \$200, and up to 4 hours - \$225. Maximum rental time is 4 hours.
2. All payments must be **either check or money order payable to "Perry Hall Recreation & Parks Council" or payments via Zelle® (phrecplayground@gmail.com)**. Checks returned by the bank will incur a \$25 service fee.
3. All rentals are "**rain or shine**" without any refunds due to weather. Refunds will be processed only with written notice 30 days or more **prior** to the rental period.
4. No alcoholic beverages are permitted on any portion of Angel Park. Glass or breakable containers are not allowed. Violation of the alcoholic beverage ban will result in immediate termination of the rental agreement and participants will be asked to leave the Park. All amounts paid will be forfeited.
5. Once approved, you will receive a signed Permit that must be prominently displayed for all to see.
6. Electrical outlets are provided and are believed to be operating. Music may be played but may not be set to a volume level that disturbs other patrons of Angel Park.
7. Items not allowed – items such as "Moon-bounces", inflatables, pony rides, carnival rides, kiddie pools, etc. are not allowed in Angel Park.
8. Charcoal or propane grills are not allowed.
9. Any permit issued may be terminated immediately for violations of any Rules of Angel Park without refund.
10. Use of Angel Park and its facilities is at the sole risk of the users.
